- ✓ Independent thresholds can be set up for **HOME** (occupied) and **AWAY** (unoccupied) modes.

The system can be set to provide online monitoring of water usage over holiday breaks. The system also allows a House Corporation officer to shut off the water with a simple online push of a button, or to set water flow restrictions to shut off the water if a certain number of gallons flow within a 30-minute window. Further, the product offers remote water monitors that can be used for monitoring unintended water flow from sinks, toilet, washers and dryers, water heaters or any other device using water within the chapter home.
